- In reference to the proposed budget for 2015, the goal is to keep the annual assessments at \$130/household. We don't see a need to raise it now. There are some adjustments though. See the 2015 budget for changes. The total allowance will still be at \$32,110.
- There was a question about where to list the plaques & memorial tree: It was decided that it best fits under landscape.
- John: Do we have a contract with the landscapers.

Chris: We'll have to approach Keith in January. It is possible that the

fees for Countryside might raise our costs.

John: We don't have much room in budget.

Chris: We do have a buffer and the capital savings if necessary.

Communications:

Annual Meeting: November 3, 7:00 PM, at the Bear Library

We will include an insert regarding Neighborhood Resources as our method for collecting delinquent assessments.

The Notice of Meeting needs to be in the mail at least 10 days prior to the Annual Meeting.

Landscape:

John: In reference to the bulbs in the lamps on the entrance sign... The last two were put in a few weeks ago and again today (10-22-14). We'll have to invest in more long lasting bulbs in the future.

Snow plow: Countryside is buying all new equipment. We've had contract for 5 years now. 5% increase is too much.

We can decide to make decisions on ice salting or let them make decisions about that.

Countryside is only responsible for damage to mailboxes if the plow actually hits them (not for damage caused by snow & ice itself).

We can receive priority mobilization: extra charge would be \$50/truck per hour.

We haven't needed this in the past... They take care of us pretty quick anyway since we are so close to their business location.

Old Business:

Memorial plaques— They will be done by the 30th.
 They can be installed and left to settle, and the ceremony would be done in the spring.

New Business:

- New policy regarding Nationwide Insurance
- Propose 2015 budget
 A motion was made to accept the budget
 Linda: I make a motion

Chris: 2nd?

Joe: Yes, I second it.

Chris: Do we have it acceptable for the community to vote during the Annual Meeting? All those in favor of approving the budget. All replied in the affirmative.

Sharon: Do we give an accounting of delinquencies.

Chris: No, that is a privacy issue.

Snow Plow Contract: For 2014-15, which levels of control do we need?
 We need to go through that first.

Chris: I will put forth a motion to accept the contract. Do I have a 2^{nd} ? Ioe: Second

Sub-motions:

 Clearing—We can opt for clearing at 1, 2, 3 inches. They will clear at four inches for sure. Last year we chose for removal to begin at 2 inches.

Nada: It was good enough last year.

John: Yeah, other developments were not as good as ours.

Chris: I make a motion to accept the removal time at 2 inches.

John: I second that.

Chris: Any objections? (No response)

Chris: I'd say 4 inches after the initial 2 is plowed.

 Salting—Apply salt only where we want or let Countryside make the decision...

Chris: Is there any objection to letting Countryside make the decision about when to apply salt? (No objections)

Priority Plowing—It costs \$50/truck/hour. These trucks begin when the snow is at 2 inches.

Chris: Is there any objections to using this equipment? (No) Main motion:

Chris: Any other questions regarding the contract?

Chris: This closes the discussion. All in favor, say "Aye." (No oppositions)

o Chris will let Keith at Countryside know we have a contract.
